### Any suggestions on policy for the new government?

What was missing in the last two years' regime was support and commitment from the government for real estate and infrastructure sector which were constantly kept under pressure with frequent policy shift. Accordingly both sectors failed to give good results to the end user, Frequent change or policies meant that you had to take a break in ongoing construction and go back to get plans re-approved, go to authorities in pursuance of new directives every now and then. I hope the Centre, state and BMC can jointly align to solve all issues and focus on making Mumbai a destination of International reckoning and provide impetusfor rental housing. A Mumbai make over can only happen if Fortune 500 companies with FDI's and local investors including land owners believe that the Govt. & local authority wish to increase their revenue through development process and not through unjustified legislations to increase its revenues and the incremental revenues are genuinely utilised for augmentation of infrastructures.

## How do you describe your latest flagship project JADE GARDENS coming from Happy Home Group? Do you have the intention to transform the area completely?

With design architects Talati and Panthaky Associated (TPA), We wanted to create an iconic building which would set standards for a redeveloped property. This project is also showcased by MHADA to Delhi Development Authority as successful redevelopment model of Mumbai.

Jade Gardens was completed in just 30 months with occupation certificate (OC). There are three towers/ wings which rehoused all 80 society members in apartments of 2-3 BHK, with initially 40 sale apartments and 45 sale apartments later on. With plenty of indoor and Outdoor amenities like Grand entrance lobby, gymnasium, Kids play area, A/c community hall, Spa with steam and Jacuzzi. Outdoor amenities include terrace landscaping with dedicated area for children and senior citizens along with view decks and a large Jogging track. All this, in a timebound programme, was achieved because of transparency and support between both ends - the developer and the society members. Jade Gardens was the first project to take the redevelopment initiative in its surrounding area. We built the project in the targeted time frame.
